1. PRODUCT DESCRIPTION:

Bi-O-Lion: rubber material for sealing gland.

Bi-O-Lion is a fluorocarbon terpolymer based synthetic rubber, reinforced with carbon black & peroxide cured. It is specially compounded to have enhanced resistance to Environmentally Acceptable Lubricants (EAL).

Temperature range: -16°C to 210°C (3°F to 410°F)

- 4.1 Material intended for Oil Lubricated Propeller Shaft Seals.
- 4.2 This sealing gland system is eligible for Tailshaft Modified Survey Periodicity as per BV Rules NR 467 Part A Ch 2 Sec2 [5.5.3] provided that all the requirements are complied with (depending on the material of the shaft, the keyway, the oil analysis and consumption recorder, the monitoring of stern tube bearing temperature and the nature of the protection against corrosion).
- 4.3 This sealing gland system is compatible with the requirements of additional notation MON-SHAFT (BV Rules NR467 Part F Ch 5, Sec 2) provided that all other requirements are complied with.
- 4.4 Due consideration is to be paid to the Manufacturer's recommendations concerning the installation, inspection, operation and maintenance of the seal.
